Privacy Policy

Weightlifting Wales is committed to processing personal information about its customers, members and partners in ways that comply with its legal and regulatory obligations, and to being clear with customers, members and partners about what it does with their personal information.

This policy explains how we use any personal information we may collect about you when you use our websites; or when you use or are a recipient of our services.

Personal information that Weightlifting Wales may collect about you

Weightlifting Wales may collect personal information which we receive when:

- you use our website
- you use our services
- you contact us

We may collect the following types of information:

- your name, address, email address, telephone number(s) and other contact details;
- information required to provide you with a service, and details of our services that you have used;
- your company's name, your position in Weightlifting Wales; Weightlifting Wales's address, company's email address and telephone number;
- your payment information such as credit or debit card details, if relevant;
- information collected through your use of Weightlifting Wales website. Please see the Cookies procedure below for more information;
- details of any enquiry or complaint you make to Weightlifting Wales.

Why Weightlifting Wales collects personal information

Weightlifting Wales collects your personal information to:

- provide you with products and services that you may request from us or selected third parties;
- enhance or improve users experience of our products and services and our website;
- improve and develop Weightlifting Wales's services;
- protect security e.g. to check your identity when you use our services, if relevant;
- meet its legal and regulatory obligations.

If you call any of our telephone numbers, we may record your call. These recordings are used for training and quality control, to ensure that we continuously monitor and improve our customer service standards.

How Weightlifting Wales collects personal information

Weightlifting Wales collects personal information:

- Directly from customers: e.g. when a customer signs up to receive our services (i.e. becoming a Weightlifting Wales member) or registers on a service through the Weightlifting Wales website.
- From third parties: e.g. when we acquire third party marketing lists or information from the electoral roll; get authorisation for a payment you make, or when undertaking an identity check, if relevant.
- When products or services are provided together with a business partner and the information is collected by the business partner in order for Weightlifting Wales to provide you with the product or service, if relevant.

Individuals' personal information may be provided to selected third parties:

where individuals have indicated they wish to receive information about products, services

or promotions that may be of interest to them;

where services are provided together with a business partner, and it is necessary to disclose

the information to them in order to provide the services;

for the prevention of fraud against Weightlifting Wales, third parties and the individuals

using the online services themselves;

for the purposes of identity verification;

to prevent money laundering;

where products and services are provided to third parties by Weightlifting Wales e.g. for the

purposes of identity verification and fraud prevention, and it is necessary to disclose

information to them in order to provide the service.

Other third parties (including the police, law enforcement agencies, credit reference and

fraud prevention agencies and other bodies) to protect our or another person's rights,

property, or safety e.g.

to exchange information to protect against fraud and to reduce payment risks, if relevant;

and

• in connection with the prevention and detection of crime.

Transfer of personal information outside of the UK

Weightlifting Wales may need to transfer personal information about its customers to third

parties located outside the UK. If we do, we will ensure that information is protected to a level

which meets the requirements of UK law.

Weightlifting Wales is committed to keeping customers' and partners' personal information secure to protect it from being inappropriately or accidentally accessed, used, shared or destroyed, and against it being lost.

How long we keep personal information

Weightlifting Wales will only retain individuals' personal information for as long as it needs it to carry out a particular purpose or meet a particular obligation.

Keeping personal information accurate

Weightlifting Wales will ensure that personal information is kept accurate and up to date as far as is reasonably possible. However, Weightlifting Wales relies on customers and partners to ensure that some of the information it holds about them is accurate and up-to-date. We encourage customers and partners to inform Weightlifting Wales of any changes to their information.

Access to personal information

Weightlifting Wales provides customers and partners with access to their personal information and the opportunity to amend and update their details or preferences in order to keep the information up-to-date and accurate.

You can request details of personal information Weightlifting Wales holds about you, including on our websites' databases, by contacting us.

Requests must be made in writing. Proof of identification is required in order to protect your information. We also require sufficient details to be able to locate your information. For
